

## **Rural Valley Borough Council Minutes September 10, 2018**

Meeting opened by President Will Spera with flag pledge.

Bids were opened for the sale of the old SV School property. Only one bid received from Dayton First Church of God for \$5,000 contingent upon the vote of the congregation. Plan for use is a community coffee shop, R&P Coffee Co. Dan Hill and Bre Sherman discussed the planned use of the building.

Frank Palilla moved to accept the minutes of August 13, 2018. Randy Arduini seconded. Minutes accepted.

Randy Arduini moved to accept the treasurer's report. Tony Arduini seconded. Report accepted.

Randy Arduini moved to pay the bills, which included Highway Aid bills to NuMine Pipe Supply, Inv. 116463 & 116527 totaling \$700.60 for drainage pipe to M&M Lime Co. for Inv. 2045 for \$911.92, and to HEI-WAY, LLC for Inv. 80810004 for \$209.40. Tony Arduini seconded. Motion accepted.

Randy Arduini moved to accept the bid of \$5,000 for the sale of the old SV School contingent upon the congregation vote from Dayton First Church of God. Tony Arduini seconded. Motion accepted.
